




**Build institutional support** for knowledge mobilization and encourage collaboration to connect research, policies, and innovations

# RIC Narrative CV Working Group (RIC NCWG)

- The RIC NCWG came together organically through shared interest among RIC member institutions following national developments in the adoption of Narrative CVs by Tri-Agency Councils.
- Recognizing that many RIC members were experimenting with or supporting narrative CV implementation on their campuses, the group was created as a space to exchange insights, resources, and lessons learned.



# RIC Narrative CV Working Group

- Since its formation, the RIC Narrative CV Working Group has focused on:
  - Sharing practices and models from across Canada to inform institutional approaches to narrative CVs.
  - Exploring how narrative CVs can help shift research culture toward valuing diverse contributions and inclusive definitions of impact.
  - Developing guidance and tools to support researchers, administrators, and reviewers in adopting and assessing narrative formats.
  - Connecting with national partners to align RIC's work with broader movements in research assessment reform
- Through collaboration, the group aims to help each other through this new shift with Narrative CVs

# Narrative CVs: Building Supports

- **Institutions have different levels of:**
  - experience with research assessment reform, DORA
  - capacity to develop supports for research communities
- **Exploring the appropriate mix of support-building opportunities:**
  - Balancing our own team capacities with need to engage with researchers across institution
  - Train-the-trainers; collaboration with capacity-support teams; grants & awards teams

# What We're Doing to Help

- **Asynchronous:** recorded info sessions and webinars; prompt questions; FAQs; online guides and tools
- **Synchronous:** online “office hours”; info sessions and webinars; hands-on workshops; breakout sessions; impact-data source orientations
- **Resource example:**
  - UCalgary's MSC Guide (being expanded into a full **TCV Guide**)
  - Testing the principles and 4-step process through workshops and consultations with faculty and researchers

# Building Exposure & Familiarity

- Adopt narrative CV format for internal awards/funding/opportunities
  - E.g., Postdoctoral award processes, internal seed/catalyst/accelerator grants, etc.
- An opportunity to discuss/teach about new approaches to documenting & communicating **research quality & impact**
- Integration with hiring, promotion, performance reviews?

# Evolving Rollout & Timing

- Transition timing is evolving; staying agile
  - CV-FRQ moving ahead now / TCV not fully integrated until 2027 competitions
- Opportunity to support Québec institutions
- Test resources, gather feedback, draw lessons
- Multiple competitions with MSC sections; every cycle offers new learnings and examples

# Learning Through Consultation

- We need to be seeing both good and ‘not-so-good’ examples of TCVs/CVs-FRQ
- Consults are important learning opportunities and experiences for us
- Look for “**data saturation**”: repeated barriers/roadblocks/obstacles/challenges/misconceptions
  - Sets of ready-made ‘fixes’ to address common concerns, FAQs, etc.
- How to balance: individual-level engagements with team capacity constraints
  - equitable distribution of consultations is a consideration
- Until we see reviewers’ ratings/reactions, we will be taking ‘best guesses’
  - E.g., “do I have to write my narrative CV using first-person POV?”



- Released in summer - available in EN and translated to FR
- Breaking the task down into steps and building blocks
- Establishing common definitions around research impact
- DOs and DON'Ts, checklists, tooltips
- Multiple formats (PDF & web-based)
- Adapting this to full TCV Guide
- Pressure testing this even after release!



**A Guide To Writing A 'Most Significant Contributions' (MSC) Statement**  
Knowledge to Impact  
v.1|2025

This guide has been developed by the Knowledge to Impact team, Research Services Office (RSO), at the University of Calgary. It is intended to support University faculty, staff, students and partners that require a statement of significant contributions, including as part of a larger narrative CV (e.g., [Tri-Agency CV](#)).

**What is a MSC Statement and why do I need one?**

'Most Significant Contributions' (MSC) statements allow researchers to communicate and contextualize their achievements and impact for any number of opportunities including funding and award applications, career advancement, and other profile-building opportunities. A well-written MSC allows you to tell a unique story about the value and impact of your research.

In contrast to more traditional list-based CVs or resumes, MSCs are written accounts of your research contributions (i.e., narrative-based) and are intended to highlight the full spectrum of your research outputs. MSCs should be tailored to the target audience(s) and each specific opportunity, and should clearly explain the quality, significance, and/or value of your work – with examples and evidence in support of your claims.

An MSC may be a standalone document, or may be one component of a larger narrative CV, such as the [Tri-Agency CV](#). With its emphasis on context, a mix of qualitative and quantitative evidence, and a broad range of contributions, it is a [DORA-aligned](#) evidence-based account of your key research achievements, tailored to the audience(s) evaluating it.

 **The MSC Statement** is part of the unique story about your research. Use this section to highlight the significance of your work that is most relevant for the opportunity at hand.

**How to write a MSC Statement**

Each MSC should be written with the requirements of your specific opportunity in mind. Think about your experiences, outputs, and contributions that will make you the right fit for this job, opportunity, or project.

**Getting Started: 4 Steps**

- 1 LIST research contributions & activities
- 2 DEFINE & describe your role
- 3 DESCRIBE & document the impact
- 4 SUPPORT your impact with evidence
